NO TRANSACTION OR PURCHASE NECESSARY: TCF Bank “Dell Netbook Sweepstakes” is open to any U.S. resident, 18 years or older, except employees of TCF National Bank, SuperValu, their affiliates and subsidiaries, immediate families, as well as employees of their advertising and promotion agencies, sales representatives, printers and their families as defined by Section 267 (c) of the Internal Revenue Code.

HOW TO ENTER: After you sign up to receive online statements by May 31, 2010, you will be automatically entered into the “Dell Netbook Sweepstakes”. If a TCF customer has already signed up to receive online statements, they will be automatically entered. To enter the Sweepstakes via mail, submit your entry together with your name, complete home address (no P.O. Boxes) and day/home telephone number. Mail entry in a stamped envelope to TCF Bank “Dell Netbook Sweepstakes”, 801 Marquette Ave., Suite 201, MC 001-02-N, Minneapolis, MN 55402. All entries must be mailed separately and received by May 31, 2010. One entry per person only (either by being automatically entered or mail-in). Mechanical reproduction entries not valid.

ODDS OF WINNING: Odds of winning depend upon the number of entries received. TCF Marketing will randomly select a total of ten (10) Grand Prize Winners on or around July 6, 2010. The Winners will receive one (1) Dell Netbook. Need not be present to win. The Winners will be notified by the email account used to access their online statements the day of the drawing.
